NORTH SOMERSET COUNCIL – AREA SPECIFIC PUBLIC SPACE PROTECTION ORDERS (PSPOs) FOR THE PARISH OF HUTTON

There are North Somerset Council Area Specific Public Space Protection Orders (PSPOs) in place **for the Parish of Hutton for the following areas:**

- **Des Phippen Park**

All dogs are required to be kept on a lead - in the area indicted on the plan below.

- **Springwood Recreation Ground**

All dogs are required to be kept on a lead - in the area indicated on the plan below.

- **Jubilee Sports Field**

No dogs - except assistance dogs - in the area indicated on the plan below.

- **St Mary's Field**

No dogs - except assistance dogs - in the area indicated on the plan below.

North Somerset Council PSPOs are intended to deal with a particular nuisance or problem in a specific area that is detrimental to the local community's quality of life. They work by imposing conditions on the use of that area which apply to everyone. They are intended to make sure that everyone can use and enjoy public spaces, safe from **anti-social behaviour**. A PSPO can set out blanket restrictions and/or requirements or can be targeted against certain behaviours by certain groups at certain times.

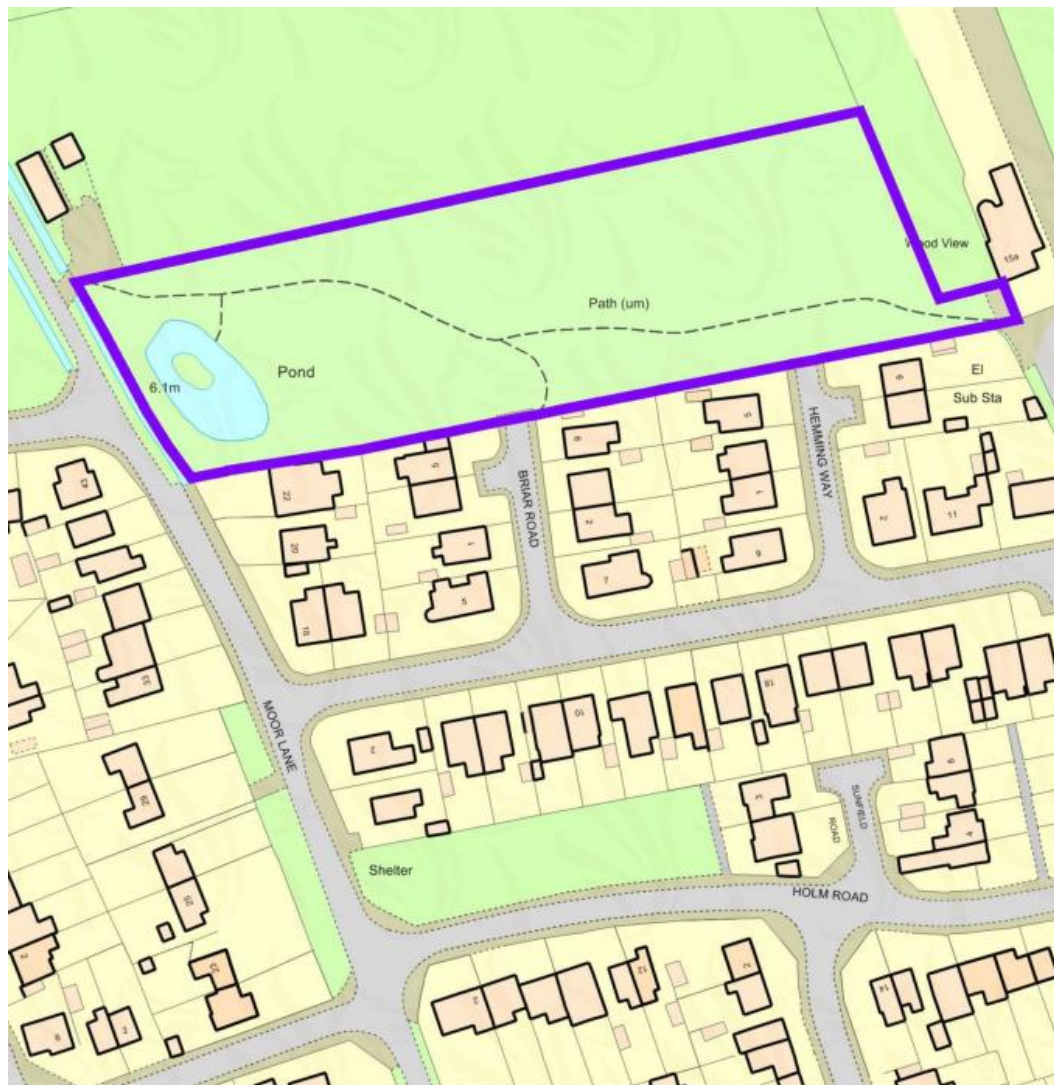

Restriction - All dogs are required to be kept on a lead.

Restriction - No dogs - except assistance dogs.

Restriction - No dogs - except assistance dogs.

If a Police Constable or Authorised Person reasonably believes that a person has acted contrary to the restrictions placed upon them by the order, they must provide their name and address when required to do so.
